There will be information from the Idaho Coalition for Safe Healthcare (ICSH), a new group of physicians and other medical professionals advocating for Idahoans to have access to safe and evidence-based healthcare including reproductive health care and care for LGBTQ+ communities. This will be a casual evening to learn and meet others interested in advocacy.

We want pediatric healthcare clinicians to be up to date on what is happening at the state level now, and to strategize on how to advocate over the long-term. We are in the middle of the legislative session and several issues have come up that are pertinent to caring for youth in Idaho:

-Mandating parental consent for all minors under age 18 to receive any healthcare information or treatment.


-Medicaid funding and expansion.

- -Changing IRIS to be opt-in rather than opt-out.
- -Reestablishing the maternal mortality review committee.
- -Further restrictions on transgender people.
- -Changes to concussion laws.
